Welcome to the 2024 Williamstown Football Club Annual Report.

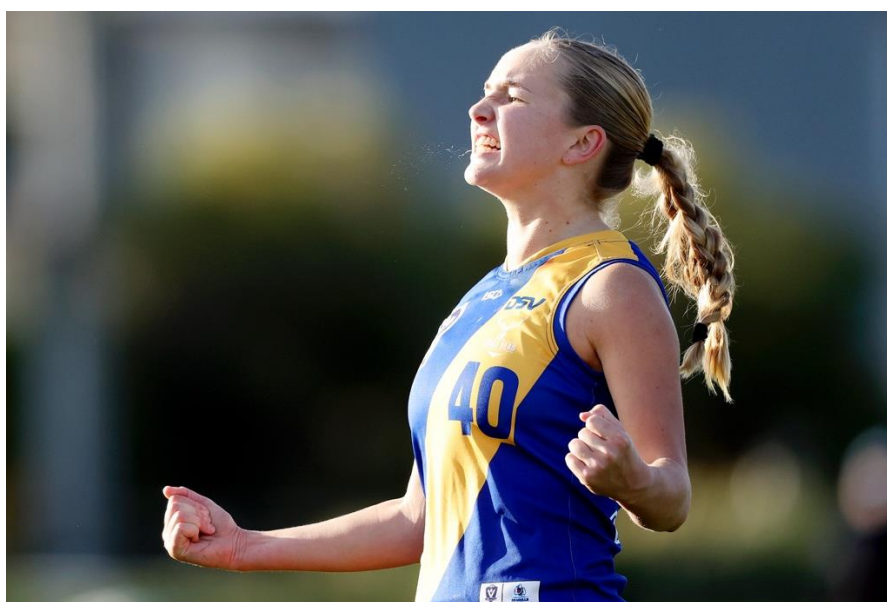

Financial Report



Williamstown Football Club is recording an audited surplus of \$289,690 for the financial year ending 31 October 2024. This was a reversal of last year's deficit of \$419,873. Whilst the Club was able to post a surplus, there have been some challenges in achieving this result which are ongoing.

As such, I'd like to highlight some key areas within the financial reports.

The first is that our revenues from sponsors have once again increased in the last 12 months and our loyal membership base has also increased. Without this assistance and continual support of our Club, we would be in a very different position. Conversely, our function and events revenue were lower than anticipated. This included our revenues from our Seaview Event Centre.

This downturn in function and events revenue coupled with the ongoing gaming license fees impacted on our trading cashflows. Whilst the interest charged on the license fee is reducing each year, a capital repayment of \$445,604 each year until August 2029 is a significant commitment. That said, we have retained our liquidity through our future fund growth and returns to soften this ongoing blow.

Newport Social also had a mixed year. In difficult conditions, we experienced a similar contribution to 2023. We cannot stress enough the importance of this contribution from this venue as it enables the Club to allocate the necessary resources across both the Football Programs, as well as the staff which support these programs, to create a successful environment which we all benefit from. This includes the members, supporters and all key stakeholders. This would not be possible without the guidance, support and understanding of the Francis Family, who help the Club manage the venue. To Ian and Tom Francis, thank you again!

The Club also remained focused on the retention of capital in our future fund. The power of compounding is ever present and contributes the liquidity to our balance sheets. Our advisers for our future fund, JBWere, and in particular, Chris O'Connor and his team, were once again instrumental in posting a positive return on our investment for the year.

Later in the year, we began preparation for the facility upgrade at DSV Stadium. We are super excited about this development and trust that the initial stages will deliver a solid platform to create a first-class sporting precinct for the community, which caters for all.

A copy of the Statement of Profit/Loss and Comprehensive Income; Statement of Financial Position; Statement of changes in Equity; and Statement of Cash Flows is attached. A full copy of the audited financial results is available for inspection at the club offices. The Club's finances remain in order with the key takeaway being a strong liquid balance sheet. We will continue to strive through the ever-changing landscape in which we operate to ensure we are

able to capitalise on opportunities whilst delivering the best possible outcomes for our members, key stakeholders and our football programs.

Finally, I would like to acknowledge the contribution of Shaun Fenech from Manage My Accounts along with my fellow board members on the Finance Committee during the course of the year including Clint Rippon, Michael Howlett and David Ginnane. My last shout out is to the retired Kim Kershaw. Your guidance, determination and professionalism embody the Clubs values, and you will be missed at our meetings.
